

FITTING INSTRUCTIONS FOR R&G LICENCE PLATE HANGER

HONDA CBR954 FIREBLADE 2002-3 (part code LP0044BK)



- NOTE YOU WILL NEED TO GLUE THE LIGHT SHROUD TO THE LED LICENCE PLATE LIGHT BEFORE FITTING USING SUPER GLUE.
- Remove both seats
- Remove rear seat cowling
- Disconnect wiring to original number plate unit
- Undo the bolts holding the original number plate unit to the bike
- Remove OEM indicators from original unit
- Fit OEM or after-market indicators to new tail-tidy (R&G product code RG370)
- Offer new tail-tidy unit up over existing under tray /tail unit mount
- If using OEM indicators secure as original
- If using after-market indicators use metal insert from OEM indicators on inside of under-tray mount to secure new tail-tidy using M6 button head screws, washers and nuts supplied.
- Feed indicator and new No plate light wires through original wiring holes
- Connect No plate wires ie; black to brown and red to green (suggest cutting connector from OEM unit and splicing to R&G unit using connectors supplied)
- IMPORTANT: IF FITTING A FULL-SIZE LICENCE PLATE AND PLACING IT FAR DOWN ON THE LICENCE PLATE HANGER, THERE IS A SMALL CHANCE OF THE LICENCE PLATE HITTING THE BACK WHEEL UNDER HEAVY LOAD AND OVER LARGE BUMPS IN THE ROAD. IT IS YOUR RESPONSIBILITY TO CHECK FOR THIS POSSIBILITY AND TAKE AVOIDING ACTION. FAILURE TO CHECK THIS COULD RESULT IN SERIOUS INJURY.
- Recheck that wires are not touching exhaust silencer
- Tighten screws securing tail-tidy to under-tray/mount
- Refit rear cowling
- Refit seats
- Depending on local laws, attach enclosed red reflective tape in an appropriate location
- Test the indicators and licence plate illuminator before riding

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P - at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
