

# FITTING INSTRUCTIONS FOR CP0209BL CRASH PROTECTORS BMW G650 X MOTO







Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

## Left-hand side (as you sit on bike)

- Remove the engine bolt from frame recess arrowed above left
- Install the shorter M10 (85mm) bolt and a washer into bobbin counter bore, place the mid size spacer (9mm wide) over the free end of bolt (spacer fits between bobbin and frame) and fit this assembly into the frame recess
- Tighten bolt until you feel some compression from inside the protector. **PLEASE NOTE BOBBIN MUST BE POSITIONED AS PICTURED ABOVE WITH BIGGER END TOWARD FRONT OF BIKE.** Turn a little more so that you feel the compression increase slightly. Then apply a quarter turn. Do not overtighten as damage can occur to the bike. Do not exceed 40nm of torque.
- Install bobbin cap into bobbin (it clips in)
- If not already fitted peel and stick bubble sticker as shown above



## Right-hand side (as you sit on bike)

- Remove the engine bolt from frame recess arrowed above right
- Install the longer M10 (110mm) bolt and a washer into bobbin counter bore, place the two remaining spacers (12mm & 3mm wide) over the free end of bolt (spacers fits between bobbin and frame) and fit this assembly into the frame recess
- Tighten bolt until you feel some compression from inside the protector. **PLEASE NOTE BOBBIN MUST BE POSITIONED AS PICTURED ABOVE WITH BIGGER END TOWARD FRONT OF BIKE.** Turn a little more so that you feel the compression increase slightly. Then apply a quarter turn. Do not overtighten as damage can occur to the bike. Do not exceed 40nm of torque.
- Install bobbin cap into bobbin (it clips in)
- If not already fitted peel and stick bubble sticker as shown above

### **R&G RACING RETURNS POLICY (NON-FAULTY GOODS)**

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
