

# FITTING INSTRUCTIONS FOR LP0051BK TAIL TIDY / LICENCE PLATE HOLDER KTM 990R SUPER DUKE



## Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber* washers should be thrown away!

- NOTE YOU WILL NEED TO GLUE THE LIGHT SHROUD TO THE LED LICENCE PLATE LIGHT USING A
  SMALL AMOUNT OF SUPER GLUE.
- Remove seat and rear cowling.
- Remove OEM licence plate holder (remove cable cover to gain access to 4 bolts).
- Disconnect wiring plug.
- If not already fitted to new tail tidy, mount the new micro indicators and the new tail tidy light supplied in kit (wiring may be tidied up by using heat-shrink supplied) and secure in place.
- Offer the tail tidy into position and insert the 2 longer spacers from the kit on the front-most holes (so that the spacers fit between bracket and plastic under tray).
- Using the 2 button head screws from the kit, secure tail tidy in place (do not fully tighten yet).
- Take the 2 OEM screws and short tapered spacers from the kit (spacers go between the tail tidy and the screw head) and insert them through the rear-most holes to secure the tail tidy into place and tighten all four screws.
- Reconnect the new tail tidy light and the indicator wiring using the connectors supplied (we suggest cutting OEM loom and reusing plug). Note: it may be necessary to use the resistors supplied in the kit to ensure that indicators work at the correct speed
- Check all mechanical and electrical connections.
- Refit the rear cowling and the seat
- Ensure all lights and indicators are working correctly before proper use.

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
