


FITTING INSTRUCTIONS FOR ECC0014 LHS ENGINE CASE COVER KTM LC8 (NOT RC8)



In this kit there should be:

1 x Engine Case Cover

2 x M6 button head bolts (40mm TOP)

2 x M6 button head bolt (35mm BOTTOM)

4 x M6 washers

4 x Black spacers

1 x 25mm length of heat shrink

PLEASE READ THESE INSTRUCTIONS FULLY BEFORE STARTING

- Please make sure the engine is cold before proceeding with the fitting of the R&G cover
- Remove the four engine case bolts arrowed above. Hold the cover loosely over the case to help identify the correct ones. DO NOT REMOVE ALL OF THE CASE BOLTS.
- Remove the protective film from the R&G cover. Note there is a peel here sticker to show you where
 to start
- Place one of the M6 washers over one of the M6 button head bolts supplied in the kit.

- Slide these through one of the mounting holes in the cover.
- Slide one of the small black spacers supplied in the kit over the bolt and up to the cover.
- Cut off a piece about 3mm long, of the heat shrink supplied in the kit.
- Slide the piece of heat shrink over the thread of the bolt and up to the spacer.
- Warm up the heat shrink with a hot air gun (a hairdryer will do) this will hold the assembly together to make it easier to fit to the bike.
- Repeat this procedure for the other three bolts.
- When all four of the bolts are in position offer up the R&G cover to the engine and carefully fit it over the engine casing. Ensure that the four bolts are lined up with the holes in the engine casing, and then push on as far as it will go.
- With a 4mm Allen key tighten the bolts equally so that they pull the cover into place. DO NOT FULLY TIGHTEN.
- Finally use a torque wrench set at 10 nm (7 Lb ft) to fully tighten.
- Buff / polish any residue left from the protective film.
- It is suggested that you check the tightness of the mounting bolts on a regular basis i.e. when cleaning or once a month.
- NOTE for the cleaning of this product you should only use a soft polishing cloth and a mild general cleaning agent
- AVOID HARMFUL CHEMICALS IF IN DOUBT DO NOT USE AS THEY COULD ALTER THE STRENGTH OF THE COVER.
- R&G will accept no liability if the above procedure and torque settings are not followed.

Other than identified above and subject to R&G not limiting its liability for causing death and personal injury, it shall not be liable for indirect or consequential loss and otherwise its liability shall be limited to the amounts paid by the Buyer for the Products or the fitting or service concerned. These terms do not affect the Buyer's statutory rights.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
